Dear Mr. Sanchez:

This letter is to advise you of the intention of the Long Island Rail Road ("LIRR" or "Carrier") to utilize a third party contractor for certain work involved in the above-referenced project.

The purpose of this project is to bring the Mastic-Shirley station to a state of good repair by replacing various station components and to increase bike accessibility at Bellport, Greenvale, Lawrence, Medford, and West Hempstead stations in accordance with the MTA Bike, Pedestrian, and Micromobility Strategic Action Plan. Substantial amounts of force account support are involved in this project, including several electrical work requirements by LIRR Engineering. The work intended to be contracted out and the Division of Labor for this project is enclosed to this letter under separate cover.

Please be advised that we do not believe this is a violation of the Scope Rule of the Agreement and hereby provide you this information and notification for awareness.
